**a) REALISTIC BREAST AREOLA: REALISTIC BREAST AREOLA CHAMPIONSHIP**

**Registration fee: US\$ 100,00**

**Test date: May 13, 2025**

**\*SINGLE PHASE IN SYNTHETIC LEATHER;**

**The championship will start at 7:30 am.**

To allow the competition to run smoothly and guarantee all participants the same possibilities, anyone who arrives after the competition start time will be admitted to an unauthorized room. This way, arrive 15 minutes early.

**MATERIAL:** Each participant is obliged to take all the necessary material for the competition (equipment: dermatograph, rotary or tebori pen, needles, pigments, pencils, wet wipes and, if desired, liquid vaseline or remover to clean the synthetic skin and its Workplace). It will be mandatory that all participants use the same synthetic skin, which will be made available by the event. **The design must be done freehand. No measuring device (calipers, compasses, rulers and the like) will be allowed.**

**OBJECTIVE:** Participants will have 30 minutes to organize their workbench and 60 minutes to create a single realistic faux leather halo according to their personal taste and style.



**TECHNIQUE:** It will be necessary to create a single realistic, three-dimensional halo. The parameters that will be evaluated will be: design/tone gradient/skin lesion/homogeneity/realism/richness of details.

**JURY:** The jury will be composed by speakers and guests of authority of the event. The judges will evaluate each individual work, with a score according to the parameters, and will choose the top 3. The judges will evaluate each individual work with a score from 1 to 5 for each required parameter (1-design, 2-tone gradient, 3-skin lesion, 4-homogeneity, 5-realism, 6-richness of detail). The sum of the evaluations will decide the first three winners in this category. Participation will be anonymous, in this way, each participant will receive a number. This number must be written on the synthetic leather, added to the letters AREOLAS. Ex: 1 (AREOLAS, participant number 1). During the evaluation phase, the jury will not know the name of the participant, nor will he be able to be present at the time of the test. To maintain anonymity, each performance will be assigned only an identification number, therefore, it is PROHIBITED to send photos to the jury, to friends or acquaintances, to post on Facebook and to publicize your work to third parties before the announcement of the winners. In case of incorrect behavior, the work will be disqualified. The top three will be announced on May 14, 2025, at the end of the first day of the event, so that they can be honored by participants during the event.

**b) BEST OF THE BEST: CHAMPIONSHIP PMU BEST OF THE BEST (FULL FACE)**

**Registration fee: US\$ 100,00**

**Test date: May 13, 2025**

**\*CLASSIFICATION PHASE IN SYNTHETIC LEATHER;**

**The championship will start at 7:30 am.**

To allow the competition to run smoothly and guarantee all participants the same possibilities, anyone who arrives after the competition start time will be admitted to an unauthorized room. This way, arrive 15 minutes early.

**MATERIAL:** Each participant is obliged to take all the necessary material for the competition (dermograph, rotary and/or tebori pen, needles, pigments, pencils, wet tissue and, if desired, vaseline or some product to clean the

synthetic skin and its Workplace). It will be mandatory that all participants use the same synthetic skin, which will be made available by the event. **The design must be done freehand. No measuring device (calipers, compasses, rulers and the like) will be allowed.**

**OBJECTIVE:** Participants will have 30 minutes to organize their bench and 3 hours to create eyebrows, eyes and lips in synthetic leather according to their personal taste and style.

**TECHNIQUES:**

**EYEBROWS** – for this category, the competitor can choose between using any of the following techniques:- Thread technique (using dermograph, rotary or tebori); - Wire technique with soft shading between the wires; - Ombré Shadow Technique.

**EYES** – it will be necessary to create artistic outline in soft shading with pixels.

**LIPS** – the objective is to create beautiful lips with smooth outline, shading and use of colors according to the candidate's taste. The parameters evaluated in each of the procedures will be: visagism / symmetry / design / shading / skin lesion / homogeneity / realism and proportion (between upper and lower lips and between the body and tail of the eyebrows) / smooth contour (lips).

**JURY:** The jury will be composed by speakers and guests of authority of the event. The judges will evaluate each individual work, with a score according to the parameters, and will choose the 6 best ones to go to the final test on a real model. The sum of the evaluations will decide the first six in this category. Participation will be anonymous, in this way, each participant will receive a number. This number should be written on the synthetic leather. It will not be allowed to write the name of the participant on the synthetic skin. Participants who write their name will be disqualified. During the evaluation phase, the jury will not know the name of the participant, and will not be able to be present at the time of the test. To maintain anonymity, each performance will be assigned only an identification number, therefore, it is PROHIBITED to send photos to the jury,

to friends or acquaintances, to post on Facebook and to publicize your work to third parties before the announcement of the winners. In case of incorrect behavior, the work will be disqualified. The top six will qualify for the final phase of the championship – the model test.

**OBJECTIVE:** Participants will have 30 minutes to organize their bench and 5 hours to create eyebrows, eyes and lips on a model, according to their personal taste and style.

### **TECHNIQUES:**

**EYEBROWS** – for this category, the competitor can choose between using any of the following techniques: Wire technique (using dermograph, rotary or tebori); Wire technique with soft shading between the wires; Ombré Shadow Technique.

**EYES** – creating outline and soft shading with pixels will be required.

**LIPS** – the aim is the creation of beautiful sensual lips with soft outline, and shading and use of colors according to the candidate's taste. The parameters evaluated in each of the procedures will be: visagism / symmetry / design / shading / skin lesion / homogeneity / realism and proportion (between upper and lower lips and between body and tail of the eyebrows) / smooth contour (lips).



**JURY:** The judges are the same ones that evaluated the synthetic leather test and will now evaluate each individual work with a score from 1 to 5 for each required parameter (1-visagism, 2-symmetry, 3-design, 4-tone gradient, 5-proportions, 6-soft lip contour, 7-skin lesion, 8-homogeneity, 9-realism). The sum of the evaluations will decide the first three winners of this category. Participation will be anonymous, in this way, each participant will receive a number and the model will also receive a number. During the evaluation phase, the jury will not know the name of the participant, and will not be able to be present at the time of the test. To maintain anonymity, each performance will be assigned only an identification number, therefore, it is PROHIBITED to send photos to the jury, to friends or acquaintances, to post on Facebook and to publicize your work to third parties before the announcement of the winners. In case of incorrect behavior, the work will be disqualified. The top three will be announced on May 14, 2025, at the end of the first day of the event, so that they can be honored by the participants during the event.

**MATERIAL:** Each participant is obliged to take all the necessary material for the competition (tebori pen, blades, pigments, pencils, wet tissue and, if desired, liquid vaseline or remover to clean the synthetic leather and your workplace). It will be mandatory that all participants use the same synthetic skin, which will be made available by the event. **The design must be done freehand. No measuring device (calipers, compasses, rulers and the like) will be allowed.**





**OBJECTIVE:** Participants will have 30 minutes to organize their bench and 60 minutes to create a pair of synthetic leather eyebrows according to their personal taste and style.

**TECHNIQUE:** It will be necessary to create a pair of eyebrows using only the THREAD technique. The parameters that will be evaluated will be: symmetry, design, realism, yarn precision, yarn depth and skin lesion, homogeneity, proportion between body and tail, yarn construction, initial yarn and tail yarn.

**JURY:** The jury will be composed by speakers and guests of authority of the event. The judges will evaluate each individual work, with a score according to the parameters, and will choose the best 8 to go to the final test in real model. The sum of the evaluations will decide the first eight in this category. Participation will be anonymous, in this way, each participant will receive a number. This number should be written on the synthetic leather. It will not be allowed to write the name of the participant on the synthetic skin. Participants who write their name will be disqualified. **JURY:** The judges are the same ones that evaluated the synthetic leather test and will now evaluate each individual work with a score from 1 to 5 for each required parameter (1- symmetry, 2- design, 3- realism, 4- yarn precision, 5- depth of hairs and skin lesion, 6- homogeneity 7- proportion between body and tail, 8- construction of hairs 9- initial hairs 10- hairs in tail). The sum of the evaluations will decide the first three winners of this category. Participation will be anonymous, in this way, each participant will receive a number and the model will also receive a number. During the evaluation phase, the jury will not know the name of the participant, and will not be able to be present at the time of the test. The sum of the evaluations will decide the first three winners in this category. Participation will be anonymous, in this way, each participant will receive a number and the model will also receive a number. During the evaluation phase, the jury will not know the name of the participant, and will not be able to be present at the time of the test. To maintain anonymity, each performance will be assigned only an identification number, therefore, it is PROHIBITED to send photos to the jury, to friends or acquaintances, to post on Facebook and to publicize your work to third parties before the announcement of the winners. **JURY:** The judges are the same ones that evaluated the faux leather trial and will now evaluate each individual work with a score from 1 to 5 for each required parameter (1- symmetry, 2- design, 3- tone gradient, 4- smooth contour 5- skin lesion, 6- homogeneity, 7- proportion between upper and lower lip). The sum of the evaluations will decide the first three winners of this category. Participation will be anonymous, in this way, each participant will receive a number and the model will also receive a number. During the evaluation phase, the jury will not know the name of the participant, and will not be able to be present at the time of the test.
